I further confirm that I have read and understood the information contained in the Branch's Hungarian-language WebTrader trading system (<https://webtrader.khertekpapier.hu>), other mobile applications and the Branch's Hungarian-language website (www.khertekpapier.hu) and that I will ensure that I monitor, understand and familiarise myself and, if necessary, with the assistance of another person who understands Hungarian, with any changes to the information.

By signing below, I also declare that the Branch has provided me with clear and detailed information on the processing of my personal data, including the information contained in the Privacy Policy (available at

www.khertekpapier.hu and the Branch's Customer Service) and the chapter on data protection and data management in the Terms and Conditions.
